 - A. Motion approving Resolution R2019-48

A resolution of the City Council of the City of Belton, Missouri directing the City Manager to exercise the City of Belton's right to terminate the contract for solid waste collection services by and between the City of Belton, Missouri and Jim's Disposal Service, LLC without cause; authorizing the City Manager to negotiate and execute certain documents necessary for the purchase of residential solid waste collection carts; and to take such other actions necessary to provide for the collection of solid waste within the City of Belton.

V. Motion to enter Executive Session to discuss matters pertaining to individually identifiable personnel records, performance ratings or records pertaining to employees or applicants for employment, according to Missouri Statute 610.021.13, and that the record be closed, and that the meeting adjourn from there. A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BELTON, MISSOURI DIRECTING THE CITY MANAGER TO EXERCISE THE CITY OF BELTON'S RIGHT TO TERMINATE THE CONTRACT FOR SOLID WASTE COLLECTION SERVICES BY AND BETWEEN THE CITY OF BELTON, MISSOURI AND JIM'S DISPOSAL SERVICE, LLC WITHOUT CAUSE; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE CERTAIN DOCUMENTS NECESSARY FOR THE PURCHASE OF RESIDENTIAL SOLID WASTE COLLECTION CARTS; AND TO TAKE SUCH OTHER ACTIONS NECESSARY TO PROVIDE FOR THE COLLECTION OF SOLID WASTE WITHIN THE CITY OF BELTON.

WHEREAS, the City Council of the City of Belton, Missouri, following compliance with the procedures set forth in Section 260.247 of the Revised Statutes of Missouri, adopted Ordinance No. 2017-4370 authorizing the City Manager to execute a contract with Jim's Disposal Service, LLC for the collection of residential solid waste within the City (the "Contract"); and

WHEREAS, Article VIII, paragraph 2 of the Contract provides that the City of Belton (the "City") may cancel or terminate the Contract at any time without cause by providing sixty (60) day written notice, by certified mail, facsimile or email to Jim's Disposal Service, LLC; and

WHEREAS, the City's purchase of residential solid waste collection carts ensures that the residents of the City receive high quality, uniform, residential solid waste collection and allows greater flexibility of options for the provision of City-wide residential solid waste collection; and

WHEREAS, the provision of residential solid waste collection is necessary to ensure that the health, safety, and welfare of the residents of the City; and

WHEREAS, the City Council of the City of Belton, Missouri determines that it is in the best interest of the citizens of the City to authorize the City Manager to terminate the Contract pursuant to Article VIII, paragraph 2, purchase residential solid waste collection carts, and take such other actions necessary to ensure the collection of residential solid waste within the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BELTON, MISSOURI AS FOLLOWS:

Section 1. The City Manager is hereby directed and authorized to prepare, execute, and provide to Jim's Disposal Service, LLC any and all documents necessary to terminate the Contract pursuant to Article VIII, paragraph 2.

Section 2. The City Manager is authorized to negotiate for the purchase of residential solid waste collection carts in an amount not to exceed Five Hundred Fifty Thousand Dollars (\$550,000) and to execute certain documents necessary to purchase said residential solid waste collection carts in substantially similar form to the document attached hereto, and incorporated herein by reference, as Exhibit A.

Section 3. The City Manager, City Clerk, and other appropriate officials of the City are hereby authorized to take such other actions necessary to provide for the collection of residential solid waste within the City of Belton, including, but not limited to, contracting with responsible parties for emergency collection of residential solid waste and preparing any and all documents necessary to receive bids from responsible parties for the long-term collection of residential solid waste within the City.

Section 4. This Resolution shall take effect and be in full force from and after its passage and approval.

Section 5. If any section, subsection, sentence, clause, phrase, or portion of this Resolution is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.
